### PHYSICAL DESCRIPTION

1 story; vinyl siding; rectangular plan; asymmetrical facade.

front gable roof with shed roof full length addition on west. concrete foundation.  
brick chimney.

center (under gable ridge) entry with simple hood supported by struts. flanking  
4/4 windows. concrete stoop.

original herringbone brick sidewalk fronts this lot.
