PHYSICAL DESCRIPTION

1 story; asbestos shingle; asymmetrical plan; asymmetrical facade.

hipped roof with lower cross gables with rake boards and stops. brick foundation.
shed roof wing on north.

windows: 1/1, single and paired; small rectangular window in gable.

enclosed, projecting corner porch on west with flat roof and small paired 1/1
windows. entry on east side of porch with small wood stoop.

fronted by original herringbone sidewalk.
